# SAP CPQ, professional edition for SAP Commerce Supplemental Terms and Conditions

This Supplement is part of an Agreement for SAP Cloud Services between SAP and Customer and applies only to SAP CPQ, professional edition for SAP Commerce. Any documents referenced in this Supplement are available upon request.

### 1. **DEFINITIONS**

**Contract Year** means a period of twelve consecutive months beginning on the first day of the Subscription Term or its annual anniversary.

**End User** means an individual or business entity that accesses the SAP Commerce application to view and/or purchase Customer goods or services.

**Gross Merchandize Value (GMV)** means the gross sales revenue for products and/or services processed via the Cloud Service.

Order means each individual sales and service order data object managed via the Cloud Service.

#### 2. CLOUD SERVICE

2.1. The Cloud Service includes features to enable End Users for self-service product configuration, product bundling, guided selling and interactive pricing, leveraging configuration models, pricing data, originating from a back-end system.

## 3. FEES

- 3.1. Usage Metric. The Usage Metrics for the Cloud Service are GMV and Orders, as specified in the Order Form.
- 3.2. GMV. For subscriptions to the Cloud Service using GMV as the Usage Metric, the initial unit includes €12,000,000 GMV per Contract year (identified in the Order Form as SAP CPQ, professional edition for SAP Commerce, GMV, access). Customer must include additional GMV in its subscription as required to cover total GMV each Contract Year. SAP will convert the Euro price to Customer's local currency using SAP standard exchange rates using SAP standard currency exchange rates, which will be made available to Customer upon request.
- 3.3. Order. Subscriptions to the Cloud Service using Orders as the Usage Metric are measured in units of 50,000 Orders per Contract Year. The initial unit is identified in the Order Form as SAP CPQ, professional edition for SAP Commerce, orders, access.

# 4. ADDITIONAL TERMS

4.1. Use Rights. SAP CPQ, professional edition for SAP Commerce includes SAP CPQ and SAP Variant Configuration and Pricing.

The use of SAP CPQ and SAP Variant Configuration and Pricing is limited to end users that access the SAP Commerce application to view and/or purchase Customer goods or services.

The Cloud Service includes access to one test and productive tenant of SAP CPQ, and access to one test and productive tenant of SAP Variant Configuration and Pricing as further detailed below. The test and productive tenant of SAP CPQ serves as the test and productive tenant of SAP CPQ, professional edition for SAP Commerce, as well as the test and productive tenant for SAP CPQ, professional edition. The test and productive tenant of SAP Variant Configuration and Pricing serves as the test and productive tenant of SAP CPQ, professional edition for SAP CPQ, professional edition.

SAP CPQ, professional edition for SAP Commerce includes 10 users of SAP CPQ, professional edition. The total disk space storage included in the usage rights for these users of SAP CPQ, professional edition, constitutes the total disk space storage included in SAP CPQ, professional edition for SAP Commerce, for the usage of SAP CPQ.

- 4.2. SAP CPQ, professional edition, test tenant. The Usage Metric for SAP CPQ, professional edition, test tenants is Tenants. A Tenant means a customer-specific instance of the Cloud Service. Customer may use test tenants for non-productive purposes only. No personal data may be uploaded to or processed in a test tenant.
  - The SAP CPQ, professional edition, test tenant also serves as the test tenant for SAP CPQ, professional edition for SAP Commerce. Each additional SAP CPQ, professional edition, test tenant purchased by Customer includes one tenant of SAP CPQ and one tenant of SAP Variant Configuration and Pricing.
- 4.3. EU Access. The EU Access option is not available for the Cloud Service.
- 4.4. SAP Cloud Platform Identity Authentication and SAP Cloud Platform Identity Provisioning. SAP CPQ, professional edition for SAP Commerce includes the use of SAP Cloud Platform Identity Authentication and SAP Cloud Platform Identity Provisioning. Use of SAP Cloud Platform Identity Authentication and SAP Cloud Platform Identity Provisioning is limited to use with the Cloud Service. SAP Cloud Platform Identity Authentication and SAP Cloud Platform Identity provisioning may not be used with any other SAP or third-party solution unless a separate subscription for such use is obtained.

### 5. ADDITIONAL TERMS

- 5.1. Identity Service. The Cloud Service includes use of SAP Cloud Platform, Identity Service, which may only be used for user authentication of Authorized Users (as defined in the GTC) of the Cloud Service.
- 5.2. Integration Application. In addition to the hosted portion of the Cloud Service, SAP makes available for download by Customer the Smart Data Integration Data Provisioning Agent (the "Integration Application"). The Integration Application may not be used to connect the Cloud Service to a third-party database licensed from SAP under a run-time license. Customer must license a full-use license from the applicable database vendor to use the Integration Application to replicate data from such database into the Cloud Solution.
