This Supplement is part of an Agreement for SAP Cloud Services between SAP and Customer and applies only to **SAP Omnichannel POS by GK (the "Cloud Service")**. Any documents referenced in this Supplement are available upon request.

1. CLOUD SERVICE

云服务

- **1.1 Cloud Service**. The Cloud Service provides a suite of solutions to support retailers to transact with consumers in a brick and mortar environment (typically B2C). This includes POS, Mobile POS and other forms of transaction processing like self-checkout and in-store kiosk etc. **云服务**。云服务提供一套解决方案,支持零售商在实体环境(通常为 B2C)中与消费者进行交易。这包括 POS、移动 POS 以及其他交易处理形式,例如,自助结账和店内自助购物亭等。
- POS by GK, basic cloud edition; and SAP Omnichannel POS by GK, cloud edition. In addition, the following options for the Cloud Service are available, if needed: SAP Omnichannel POS by GK, cloud edition, storage; and SAP Omnichannel POS by GK, cloud edition, VPN gateway. Each edition / option must be ordered separately on an Order Form. - 1.3 Data Volume. The data volume included with SAP Omnichannel POS by GK, basic cloud edition is 30,000 Items and 10,200 Transactions per Device per year (retention period 60 days). The data volume included with SAP Omnichannel POS by GK, cloud edition is 500,000 Items and 60,000 Transactions per Device per year (retention period 60 days). "Transaction" means a transaction created by a Device (e.g. can be either a POS, mobile POS, scale or stationary self-checkout device). "Item" means retail articles available at a Device.

2.1 SAP Omnichannel POS by GK, basic cloud edition and SAP Omnichannel POS by GK, cloud edition. Usage Metric for SAP Omnichannel POS by GK, basic cloud edition and SAP Omnichannel POS by GK, cloud edition is Devices. "Device" means a uniquely identifiable object and its virtual representation in the Cloud Service which has a device ID allocated to it. SAP Omnichannel Point-of-Sale by GK (基础云版本) [GK 全渠道销售点玉版本]。SAP Omnichannel Point-of-Sale by GK (玉版本) [GK 全渠道销售点云版本]。SAP Omnichannel Point-of-Sale by GK (基础云版本) [GK 全渠道销售点云版本]和 SAP Omnichannel Point-of-Sale

by **GK**(云版本)[**GK**全渠道销售点云版本]的使用指标为设备数。"设备"是指云服务中已分配设备标识的唯一可识别对象及其虚拟表示。

- **2.2 SAP Omnichannel POS by GK, cloud edition, storage**. Usage Metric for SAP Omnichannel POS by GK, cloud edition, storage is "Storage Capacity Block." "Storage Capacity Block" means a block of capacity consisting of 500 GB managed database, 8 vCores, 20GB RAM. **SAP Omnichannel Point-of-Sale by GK** (云版本) [GK 全渠道销售点云版本]存储选项。SAP Omnichannel Point-of-Sale by GK (云版本) [GK 全渠道销售点云版本]存储选项的使用指标为 "存储容量块"。 "存储容量块"是指由 500 GB 托管数据库、8 个 vCore 和 20 GB RAM 组成的容量块。
- **2.3 SAP Omnichannel POS by GK, cloud edition, VPN gateway**. Usage Metric for SAP Omnichannel POS by GK, cloud edition, VPN gateway is VPN Gateway. "VPN Gateway" means a specific type of virtual network gateway that is used to send encrypted traffic between the Cloud Service virtual network and an on-premises location over the public Internet. **SAP Omnichannel Point-of-Sale by GK** (云版本) [GK 全渠道销售点云版本]VPN 网关选项。SAP Omnichannel Point-of-Sale by GK (云版本) [GK 全渠道销售点云版本]VPN 网关选项的使用指标为 VPN 网关。"VPN 网关"是指用于通过公共互联网在云服务虚拟网络和本地位置发送加密流量的特定虚拟网络关口类型。

3. ADDITIONAL TERMS

附加条款

- 3.1 Software Installation. Customer may be required to download software from the SAP Download Center and install the software on POS devices and peripherals to enable integration with the Cloud Service. Customer is responsible for installing the software in accordance with the Documentation and applying all updates and patches to the software provided by SAP. Customer may not install or use the software or updates and patches on any other infrastructure.

1. LICENSE

许可

- 1.1 SAP grants a non-exclusive license to the SDKs for the sole purpose of Customer's use with the Cloud Service in accordance with the Agreement. Any use or customization of the SDKs is limited to use in support of Customer's internal business operations. Customer is expressly prohibited from using the SDKs to modify or customize any other software from SAP, Customer or any third party.

- **1.2** Any other use of the SDKs is subject to a separate written agreement with SAP and may require the payment of additional fees.

- 1.3 The SDKs are provided at no additional license or support fee due to SAP, "AS-IS" without warranty or support obligation of any kind. This Attachment does not amend support obligations for the Cloud Service that may exist under separate agreement for the Cloud Service. SAP Support does not apply to Customer modifications to the Cloud Service made using the SDKs.

No further rights are granted to Customer under this Agreement regarding the SDKs.
