This Supplement is part of an Agreement for SAP Cloud Services between SAP and Customer and applies only to SAP Time Management by Kronos (the "Cloud Service"). Any documents referenced in this Supplement are available upon request.

1. CLOUD SERVICE

雲端服務

The Cloud Service supports Customer to manage employee work schedules, time sheets, gross pay calculations, and time off management. The Cloud Service is available in different options: SAP Time Management by Kronos, option for hourly employees; SAP Time Management by Kronos, option for salaried employees; SAP Time Management by Kronos, option for advanced absence management; SAP Time Management by Kronos, option for advanced workforce scheduling; SAP Time Management by Kronos, option for analytics; and SAP Time Management by Kronos, option for optimized scheduling, SAP Time Management by Kronos, option for activity tracking each of which requires a separate subscription fee.

2. FEES

The Usage Metric for the Cloud Service is Users. Users are individuals authorized to access the Cloud Service. Users are measured as individuals with an active profile in the Cloud Service and/or whose data has been processed in the Cloud Service. For clarification, a single User with multiple contracts or roles such as concurrent employment or global assignments shall be counted as one User.

- 3.1. Test Tenants. The Cloud Service includes one production tenant and one partial-copy non- production tenant. The non-production tenant is limited to eighteen months of production data, and may only be used for non-production purposes. Additional tenants are available for an additional fee.
