# Introduction

- ❑ As a software solution provider you can get help from the [SAP Integration and Certification Center](#) (SAP ICC) to design and develop concepts for new integration scenarios, or to determine which of the SAP Integration and Certification Center integration scenario fits your solution best.
- ❑ An Integration Assessment can be a good starting point to kick-start a completely new integration project with the help of an SAP ICC expert. It is also valuable to review an existing integration, whether it is implemented based on SAP endorsed integration technologies, or if new technologies can help update an existing integration.
- ❑ The Integration Assessment service is available for partners looking to integrate with SAP on-premise and cloud solutions.

# Project Deliverables

- ❑ Kick-off: Typically an Integration Assessment starts with a kick-off call, where you describe your envisioned integration to an SAP ICC expert. Recommendations: SAP ICC will then come back to you with suggestions for the best possible integration points and summarize these technical recommendations within 10 business days.
- ❑ Certification: The technical recommendations will also conclude whether or not the integration can be certified as part of the SAP Integration Certification program. If certification is an option, a separate certification test will conclude the project.
